I enclose the Premises Licence LAPRE1/20/62995 amended following the grant of your application to New Premises Licence on the 17 Aug 2020;. If you believe there is a mistake in the licence or summary, please let me know as soon as possible so that it can, if agreed, be corrected.

The premises licence will last indefinitely unless it is surrendered, suspended or revoked, but will lapse in the event of the death of the holder of the premises licence or upon the licence holder becoming mentally incapable or financially insolvent.

Unless the premises are a school or community building, such as a village hall and the licence authorises the provision of regulated entertainment only, an annual fee is payable on the anniversary of the grant of the licence and when due we will remind you.

The Licensing Act 2003 makes requirements for keeping, displaying and producing the premises licence and premises licence summary whenever the premises are used for any licensable activity. A brief summary is set out below:-

- A premises licence holder must ensure that the licence or a certified copy is held on the premises to which it relates either by the licence holder or by an individual nominated for this purpose by the licence holder.
- A summary of the licence and a notice specifying the nominated individual above, must each be prominently displayed at the premises.
- The licence or a certified copy of it must be produced to a constable or an authorised person on request.
- It is an offence not to comply with any condition that may be attached to the licence, or to carry out any licensable activity at the premises that is not specified on the licence, unless in accordance with a Temporary Event Notice.

**We would strongly advise that the summary is prominently displayed at the main entrance(s) where it can be conveniently read by the responsible authorities and the public.**

If this premises licence or summary is lost, stolen, damaged or destroyed, the holder of the

licence may apply to us for a copy of the licence or summary.

Section 44 refers to the procedure that must follow should you wish to transfer the premises licence. Applications and notifications must be made in the prescribed manner and accompanied by the prescribed fee. ### **Annex 2 – Conditions consistent with the operating schedule**

\* A venue manager and suitable security shall be on site during all events where licensable activity is taking place beyond 2300 hrs.

\* A CCTV system comprising of a multi camera system will be installed at the premises capable of the following;

o The head unit (recorder) for storing the images will store such data on a hard drive or a similar quality medium (locally or accessible from a central location)

o If the head unit (recorder) is kept on the premises it must be located in a secure cabinet or other secure area, preferably out of the sight and reach of the public.

o A CD/DVD burner, USB type device or media storage database (i.e. Cloud) will also form part of the system to facilitate making copies of the footage

o The quality of the images must be of a sufficiently high standard to allow identification of the subject matter

o Cameras will cover key areas identified by the operator and Police. There should be comprehensive coverage in all areas where functions will take place and the persons attending will have access (save for toilet facilities and any other area where complete privacy is required)

o Images must be retained for a minimum period of 31 days before overwriting

o The images will be made available in reasonable time on demand by the Police and authorised officers of the London Borough of Barnet
